 Appropriate attire is a must in all classes
 Youth is (17 & under)
 Youth allowed in Men's & Ladies Gaited
 Judge's decisions are final
 English Pleasure is open to gaited horses

Entries close 3 classes ahead
 TWHBEA rules apply (TWH classes)
 Lite Shod & Trail Pleasure (shoe 3/8" x 3/4" or less)
 Bands allowed on Plantation shoes ONLY, NO double caulk
 NO Pads on any gaited horses, Open Frog, NO action devices
 Legal Plantation shoes (1-1/2"x1/2")

Each breed of horse will be judged according to its standards and rules.

Show committee reserves the right to refuse any entry they deem to be unsound or in violation of the Horse Protection Act, all horses subject to inspection.
