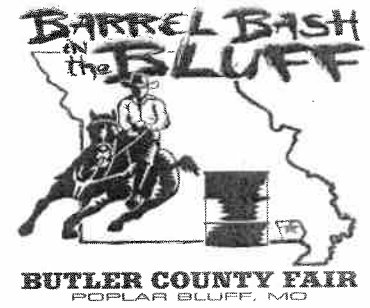

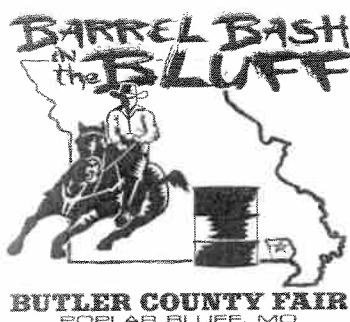

**Truck & Trailer Directions to Ray Clinton Park**

From: Hwy(s) # 60 & # 67 Jct. at Poplar Bluff, Mo. Go 6 miles East on Hwy. 60 to Exit T & AA. Make a Right and go South on Hwy. AA for 2 miles to the Stop Sign, Go Straight through the intersection & continue South on AA for 1 mile. 'After you Cross Railroad Tracks', make a Right Turn on County Road # 604, Go 2 ½ miles to the end, Go right 1 block, Then Go left to 'B' street and make a left onto 'B' Street, Ray Clinton Park Entrance will be on the right side.

From: Sikeston, Mo. Hwy. # 60 west Go 50 miles on Hwy. # 60 west to Exit T & AA. Make a Left and go South on Hwy. AA for 2 miles to the Stop Sign, Go Straight through the intersection & continue South on AA for 1 mile. 'After you Cross Railroad Tracks', make a Right Turn on County Road # 604, Go 2 ½ miles to the end, Go right 1 block, Then Go left to 'B' street and make a left onto 'B' Street, Ray Clinton Park Entrance will be on the right side.
